This memorandum details FFY2024 awards under the Emergency Solutions Grants (ESG) Program. The broad purpose of this program is to deliver housing support and related services to persons strictly defined as "homeless" or "at-risk of homelessness," as defined in federal regulations for the ESG program.

For this fiscal year, we received 184 requests for ESG funding totaling over \$14.1 million. Of the requests, \$4.7 million in funding is being awarded to 100 projects. Funding for the ESG projects comes from either (1) federal ESG funds awarded to DCA or (2) the State Housing Trust Fund for the Homeless (HTF).
